1. SOFTWARE LICENCE AGREEMENT

THE FOLLOWING LICENCE AGREEMENT REGULATES ALL USE OF RefTreeAnalyser.

This is a legal agreement between you (either an individual or an entity) and JKP Application Development Services. You should read the following terms and conditions carefully before using this software, as your use of RefTreeAnalyser indicates your acceptance of this License Agreement and Warranty.

2. Grant of License

This Software License Agreement ("License") permits you to use one copy of RefTreeAnalyser on one workstation for as long as you like. The primary user of the computer on which the RefTreeAnalyser is installed may make a second copy for his or her exclusive use on a second computer. If you have multiple Licenses for RefTreeAnalyser, then at any time you may have as many copies of RefTreeAnalyser in use as you have Licenses. RefTreeAnalyser is "in use" on a computer when it is loaded into the temporary memory (i.e. RAM) or installed into the permanent memory (e.g. hard disk, CD-ROM or other storage device) of that computer.

You may have access to RefTreeAnalyser through a network, provided that you have obtained individual Licenses for the software covering all workstations that will access the software.

3. License types and Updates

JKP Application Development Services offers two license types for RefTreeAnalyser:

Regular licenses entitle you to receive free updates to the tool for a period of one year (365 days) starting on the date of first registration. Only this license type can be purchased through our website. Once your update period has expired you will not be allowed to install or use newer versions of the tool. But you can keep using the version currently on your system and you are free to move that version on another system if necessary.

Perpetual licenses entitle you to receiving updates for the tool for as long as the tool is supported and sold by JKP Application Development Services. This license type is only available upon request.

Note that both license types allow you to use the product as long as you like, the license type only affects how long you are entitled to receive updates.

4. Copyright

RefTreeAnalyser is owned by JKP Application Development Services and is protected by copyright laws and international treaty provisions. Therefore, you must treat RefTreeAnalyser like any other copyrighted material (e.g. a book or musical recording) except that you may either (a) make one copy of RefTreeAnalyser for backup or archival purposes, or (b) transfer RefTreeAnalyser to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the user documentation provided with RefTreeAnalyser, except for your own authorized use.

5. Rights and limitations

- You may not reverse engineer, decompile, disassemble, modify, translate or make any attempt to discover the source code of RefTreeAnalyser.
- You may not create derivative works from RefTreeAnalyser.
- You may not sublicense, rent or lease RefTreeAnalyser.
- You may not assign or transfer this License to a third party

6. Limited Warranty

JKP Application Development Services warrants that RefTreeAnalyser will perform substantially in accordance with the user documentation for a period of thirty (30) days from the date of receipt. Any implied warranties on RefTreeAnalyser are limited to thirty (30) days.

7. No other warranties

JKP Application Development Services does not warrant that the functions contained within RefTreeAnalyser will meet your requirements or that the operation of the software will be uninterrupted or error free.

8. No liability for consequential damages

In no event will JKP Application Development Services be liable for any special, consequential, indirect or similar damages, including any lost profits or lost data arising out of the use or inability to use RefTreeAnalyser even if JKP Application Development Services has been advised of the possibility of such damages. In the event of any other losses, the liability of JKP Application Development Services will be limited to the cost of this License.

9. Support and Maintenance

Grant of this License does not imply continued support or maintenance of this software by JKP Application Development Services.

10. No Variation

The terms and conditions of this License may not be varied without the express written consent of JKP Application Development Services.

11. Breach by Licensee

Any breach of the terms and conditions of this License by the licensee will result in immediate termination of the licensees' rights under this License. However, while a breach limits the rights of the licensee to use RefTreeAnalyser, it in no way limits the continuing obligations of the licensee with respect to this License. In the event of a breach, all RefTreeAnalyser software and documentation must be returned to JKP Application Development Services and all traces of RefTreeAnalyser software must be deleted from computers owned or operated by the licensee. Categories of damages include, but are not limited to, lost profits on the part of JKP Application Development Services.
